Profiling and data transfer

Rights of the data subject

- **Correction:** you can ask to rectify or supplement the data you have provided us, if incorrect.
- **Cancellation:** you can request that your data are deleted, where they are no longer necessary for our purposes, in the event of withdrawal of consent or your opposition to treatment, in case of unlawful treatment, or there is a legal obligation to cancel or refer to subjects under the age of sixteen.
